SERVICES ARE INDIVIDUALIZED FOR EACH PERSON; HOWEVER, SOME COMMON AREAS OF SUPPORT AND SKILL DEVELOPMENT INCLUDE MEDICAL CARE, SOCIAL SKILLS, COMMUNITY SKILLS, DAILY LIVING SKILLS, AND SAFETY SKILLS. THE HOST HOME PROGRAM PROVIDES INDIVIDUALIZED SERVICES AND SUPPORT TO ADULT INDIVIDUALS BY PLACING THEM WITH AN INDIVIDUAL OR FAMILY TO EXPERIENCE A FAMILY OR ROOMMATE-LIKE ATMOSPHERE. THE INDEPENDENT LIVING PROGRAM OFFERS SERVICES IN THE HOMES OF INDIVIDUALS WHO HAVE THE SKILLS AND WISH TO LIVE MORE INDEPENDENTLY. THE FAMILY CAREGIVER PROGRAM ALLOWS INDIVIDUALS TO RECEIVE THEIR SERVICES DIRECTLY FROM A FAMILY MEMBER, WITH PAID SUPPORT.
